

Minutes for Friday, June 4, 2010

Mr. Love moved that it is necessary to levy a tax in excess of the ten mill limitation for the benefit of the Putnam County Board of Mental Retardation/Developmental Disabilities for the purpose of operation and maintenance for Brookhill Center at a rate not exceeding .50 mills for each one dollar of valuation, which amounts to five cents (.05) for each one hundred dollars of valuation for ten (10) years beginning with the tax year 2011, 2012, 2013, 2014, 2015, 2016, 2017, 2018, 2019 and 2020 and which levy is a replacement of an existing levy of .50 mills, and be it further resolved that the question of levying additional taxes be submitted to the electors of said Putnam County at the general election to be held at the usual voting places within said Putnam County on the 2nd day of November, 2010 and that said levy be placed upon the tax list of the current year after the February settlement next succeeding the election, if majority of the electors voting thereon vote in favor thereof and be it further resolved that the clerk of the Board of County Commissioners be and s he is hereby directed to certify a copy of this resolution to the Board of Elections, of Putnam County, Ohio and said election to be held on the 2nd day of November, 2010.
