

## Minutes for Thursday, August 1, 2013

Mr. Schroeder moved to approve a resolution declaring it necessary to levy a tax in excess of the ten mill limitation for the benefit of the Putnam County Emergency Medical Services for the purpose of providing and maintaining emergency medical services per Ohio Revised Code 5705.19(I) at a rate not exceeding .65 mills for each one dollar of valuation which amounts to 6.5 cents for each one hundred dollars of valuation, for a continuing levy beginning with the tax year 2013 and which levy is an additional. The question of levying additional taxes be submitted at the general election on November 5, 2013.
