# 2:30 p.m.

Agenda. Present were Commissioners Love, Schroeder and Jerwers; administrator Jack Betscher, clerk Betty Schroeder and Nancy Kline of the Putnam County Sentinel and Jim and Sherry Webb of Oak Haven Residential Care. After the agenda Joe Burkhart, IT director came over and talked to the Webbs. He said two phone lines there now for phone system. The elevator was just inspected John said. John said fire suppression paid up to end of month. Jim wanted the name of maintenance man and Love told him Tim Schnipke, they have his card.

# 3:00 p.m.

The investment meeting was held in the commissioners office with the following present: Tracy Warnecke, treasurer; John Love and Travis Jerwers, commissioners.

#### 3:30 p.m. – 4:25 p.m.

Greg Unverferth, president of the airport board and Barry Woodyard board member met with commissioners Love, Schroeder and Jerwers and administrator Jack Betscher regarding several issues at the airport. Also present was Charlie Morman. Greg and Barry talked about a ditch east of the airport that needs to have trees trimmed/removed. Greg said the airport does not have water draining into it, but said Ohio expanding grant to airport.. may try to submit to get the trees trimmed. Greg said the Ohio grant so restricted. Greg said changed this year 10 million instead of 4 million and up to 95/5%

on future projects. Greg said we may write up a grant to get us out of safety zone and then apply for a grant for that. Ryan Moran, deputy engineer arrived at 3:35 p.m. Barry said we would like to get all the trees taken out. Greg said take out of farming area..300 ft x 150 ft. cannot be farmed. Need to take this out. Farmland around runway needs to be taken out. Greg said they will start mowing that area 1.033 acres. Greg said want to take the trees out this fall.. Charlie Morman said don't want to take stumps out because then you will have erosion. Greg said we are going to try to go grant route and get it funded, if not attempt to take other steps. Greg said the No. 1 thing they want you to take care of is obstructions. Commissioners agreed to have them get grant. Greg said regarding advance backs, we will review at the end of the year and see if can give more back.

Greg Heaton brought up \$450,000 in grant funds, we don't have matching funds..one thing to consider, reimbursement for land..originally 38 acres Greg said, Greg said the FAA owns the underlying land, if county sells, the FAA would get their money back. Don't know details yet Greg said. We could apply for grant funds and want to be reimbursed, the FAA would be purchasing the land Greg said. Mr. Love said Greg Heaton said we couldn't sell it but we could rent it out. Greg said Greg Heaton said some airports have done this (get airports more under their control).Want you guys to be aware, that may explore the option.

Greg asked if had any questions. Vince asked about drainage, no problem Greg said. Kent and Chad doing a good job. Asked Charlie if could get a revised quote to get rid of weeds. John asked about rental of hangar and Greg said only older ones available. Allow people to pay quarterly and write in agreements payments due beginning of quarter, and say hangar payments always due at beginning of quarter.

Mr. Love said just to let you know as of today we did lease out Putnam Acres Care Center, Oak Haven Residential, independent living.

Greg said since almost Sept it was agreed to keep the management contracts same as last year.

Status of the cleanout of the tanks, Greg said couldn't do what we wanted to do. Cleanout filtering service.75 gallons were lost in one tank and 105 gallons in the other tank. It is done, \$3750 estimate. And the other process was 250 gallons lost in both tanks.

Mr. Love said appreciate the updates on the website.
