WHEREAS, The Board of County Commissioners signed a resolution on December 30, 2014, and recorded in Comm. Jrl. 106, Page 412, to adopt a personnel policy, which included a Drug and Alcohol Policy.

and

WHEREAS, Ohio's new law permits employers to maintain zero tolerance policy. Likewise, employers are not required to accommodate medical marijuana use under the Americans with Disabilities Act (ADA). Simply stated, and employee's authorized use of medical marijuana provides no additional rights or protections relative to employment.

And

WHEREAS, in similar situations, courts have ruled in favor of employers that terminated employees under a zero tolerance policy for use of medical marijuana.

RESOLVED, Putnam County has established and maintains a Drug-Free Workplace Policy that is unaffected by the Ohio Sub HB 523 or Ohio's medical marijuana law taking effect.

and be it further

RESOLVED, The Putnam County Commissioners will require that all employees sign an acknowledgment, Memorandum of Understanding regarding Medical Marijuana and the Drug-Free Workplace Policy.
