WHEREAS, The district technician for the Putnam Soil and Water Conservation District, Jeffery P. Giesige has informed the Board of County Commissioners that extra work has to be performed for the Hilty Drainage Improvement Ditch #955.

WHEREAS, The district technician stated that during construction the contractor, through no fault of his own, destroyed an unmarked electrical line as he was excavating dirt from the channel. The plastic conduit and electrical wire inside were no more than four (4) inches below the existing ditch bottom and consequently were severed during normal construction operations. The electrical line in question belongs to the Pandora Missionary Church and provided power to the church's sign along the north side of St. Rt. 12.

WHEREAS, A proposal in the amount of \$900.00 has been received from Sarka Electric, Kalida, Ohio, to repair the damaged line.

That the question of levying additional taxes be submitted to the electors of said county at the general election to be held at the usual voting places within said Putnam county on the 6th day of November, 2012 and that the levy be placed upon the tax list of the current year after the February settlement next succeeding the election, if majority of the electors voting thereon vote in favor thereof; and be it further that the clerk be directed to certify a copy of this resolution to the Board of Elections more than seventy-five (75) days prior to November 6, 2012, and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.
