Business agenda was held with Commissioners Schroeder, Jerwers and Love; Jack Betscher, Administrator; Cindy Landwehr, Clerk and Nancy Kline, Putnam County Sentinel.

10:30 a.m.

Joe Moenter, Kristi Powell and Bob Kroeger from Veteran Service Commission came in to give Commissioners Schroeder, Jerwers and Love an update on Veteran Services. Joe said there are ID cards coming out to be issued and Putnam County is set up to issue these ID cards at no charge to the Veterans. There are some businesses in the County that will offer a discount for the veterans that show their ID card. There are now Ohio Women's Veteran license plates available to purchase. Joe also said there is limited parking for the Veterans. And they still wish to have a push door.

There have been two veteran suicides in the last few months. One was in Chicago but was originally from Pandora. The rate of veteran suicides is going to increase. A list is not given to recognize the newly released veterans. Kristi is trying to reach out any new veterans that are being released from service. There is a special team that can be called for these situations, Kristi is asking if these team members are properly educated/trained. And the local suicide could have been handled differently and hopeful with a different outcome. Kristi could help and get the people suffering from PTSD into treatment if she has the ability to contact them. The Veteran Service Commission would like to get the word out that they can provide help. And the drug problem will be involved with this as well. The Sheriff office may need to be contacted regarding their protocols and training for suicide situations. Kristi said they have talked to the wife of the local suicide and let her tell the scenario of the happenings of the evening and Kristi felt that some of the events could have been handled differently and maybe there should be some more training needed. It was also discussed about referring to Pathways, Kristi said she talked to them and they are not equipped to handle these kinds of situations. So they may not be a good referral. Veteran Services have had dealings with Pathways and have a working relationship. Kristi said they would also like to know when a veteran is in jail, they may be able to offer counseling if there is drug abuse involved or even other cases. There are quite a few veterans that are employed by the County but have never been in the office to know what is available to the veterans, which may help them in their work situations. Jack suggested they go to the Sheriff and have him talk to his people and see if he will let Veteran Service Commission talk to his people to promote their services. They would rather wait until after the election. John suggested some outreach of going to trustee meetings and mayor's meetings besides the VFW, legion and AmVets meetings. The main goal is to make these people that are having problems a contributor to society and get them help. Veterans with PTSD will not harm anyone else just themselves to escape their feelings. Veterans will not talk to civilians regarding any issues, they want to talk to another service person. There is combat counseling available for families to help them readapt to civilian life. It is hard for the veterans to get back into "regular life". Veteran Services would like to reach out to the other offices that

can provide services and have dealings with these people. And verify the proper and adequate training of these people. Kristi goes to the jail to see veteran inmates and see if they are aware that they have the option to meet with the Pathways Counselor. Getting in with Paulding County veteran prisoners would be an option too, since Putnam is housing Paulding's prisoners. The services through Veteran Services are not requested until possibly after the fact. Veteran Service would like to promote education of their office and services.

Kristi also asked about policy of purchasing with a credit card. She had to purchase gas with her personal card since there was not a Shell station available.
